### **Recommendation:**

The Community Facility Advisory Board (CFAB) recommends approval by the Joint Commissions of the 2015 Organizational Funding Requests as submitted for the Dodge City Area Arts Council, Dodge City Roundup and the Dodge City Trail of Fame.

### **Background:**

CFAB met on November 19 to review and make recommendations on the 2014 Organizational Funding Applications. The requests for funding were as follows:

- Dodge City Area Arts Council: \$4,716.13
- Dodge City Roundup: \$40,000.00
- Dodge City Trail of Fame: \$22,000.00
- Ford County: \$545,000.00

**Total Requests: \$611,716.13**

CFAB voted unanimously to approve the first three Organizational Funding requests as submitted. However, the request from Ford County for \$545,000 for a livestock building at the Western State Bank Expo property was tabled until the December CFAB meeting. The County requested that CFAB evaluate this building as a "Why Not Dodge" project. The CFAB Board requested that the County work with the Director of Finance for the City to see if funding was available for the proposed project. The next CFAB meeting is scheduled for December 17.

**Justification:**

The unanimous decision by CFAB to fund the 2014 CFAB requests from the Dodge City Area Arts Council, Dodge City Roundup and the Dodge City Trail of Fame was based on the total available funding in the Organizational Funding Budget.

**Financial Considerations:**

The total available funds for 2014 Organizational Funding is \$710,000. However, per the Dodge City/Ford County Inter-local Agreement, \$600,000 is recommended by the County and the City as a priority for the County owned Expo Center and the City owned Santa Fe Depot or other Master Tourism Plan implementation projects. Therefore \$110,000 is available for other Organizational Funding requests. The total amount of recommended funding requests for 2015 is \$66,716.13. Based on the funds available and funds requested, CFAB recommends funding of the 2014 Organizational Funding requests from the Dodge City Area Arts Council, Dodge City Roundup and the Dodge City Trail of Fame.
